 Units who have already applied /send their application for participation in the said event well in advance
 need not require to apply once again.
- 2. Stalls will be allotted on the basis of draw of lots by NJB, H.O, Kolkata tentatively on 5th August 2024 and confirmation letter will be issued in due course of time. Stalls if allotted to Mills and exporters will be charged 10% of space rent as participation fee, while the stalls for artisans, entrepreneurs, WSHGs and micro units will be free.
- 3. Stall Allotment at the venue will be done either by NJB Official or by the Mela Authorities as per the instruction given by NJB H.O and Participants are requested to adhere to the Terms & Conditions of NJB & Fair Authority.
- 4. If any units, after the confirmation, defaults (or) withdraw participation 2/3 days before the event, they will be debarred from participating in the future events and a part of the stall charges will be collected from the concerned defaulting units.

You are requested to send the CONSENT Letter/application form as per NJB format duly filled, signed & stamped and send along with the above required supporting papers by hand /courier/Email, to NJB Kolkata office, before 5th August 2024 within 10.00 am.
