Sub : Minutes of the 5th Meeting of the Technical Committee of the Incentive Scheme for Acquisition of Plants and Machinery (ISAPM).

The 5th Meeting of the Technical Committee of the Incentive Scheme for Acquisition of Plants and Machinery (ISAPM) was held on 9th September, 2015 at the office of National Jute Board, Kolkata under the Chairmanship of Jute Commissioner. During the meeting the following salient points were discussed. *The detailed minutes of the Meeting and minimum price list as submitted by IJIRA are available at www.jute.com for your ready reference.*

- 1. Henceforth, application for issue of IPA and claim of incentive under ISAPM should be submitted in person by the authorized representative of the mill / JDP sector unit with prior appointment of NJB official/s, duly filled-in enclosing relevant copy of document/s, wherever necessary, to the Secretary NJB, as per the modified format (enclosed at Annexure-A & B of the detailed minutes available in the website mentioned above) for release of IPA & incentive under ISAPM. It may also be noted that a checklist for on spot scrutiny is also available in the Minutes of the 5th Meeting of the Technical Committee.
- 2. Original Invoice/s and documents of all new machinery on which incentive have been claimed after installation under ISAPM should be submitted by claimant along with bank certified statement, countersigned by the Bank Manager.
- 3. Details of RTGS, Account No. on which the incentive to be transferred, IFS Code of the bank etc. to be intimated along with the claim application
- 4. Applicant should prepare a board stating name as per format (*enclosed at Annexure-E of the detailed minutes available in the website mentioned above*) and to be placed in the concerned department mentioning department-wise statement of machinery on which Subsidy & Incentive received from NJB under JTM and ISAPM respectively for the last five years.
- IJIRA has also prepared a template, available in the website to be fixed on the gable of the machine before inspection on which claim of incentive has been made. This issues with the approval of Secretary, NJB.

Agenda-1 : <u>Confirmation of the minutes of the 4th meeting of the Technical Committee of the Incentive Scheme for Acquisition of Plants & Machinery (ISAPM) held on 13th April, 2015 at the Conference Room of NJB, Kolkata.</u>

The approved minutes of the 4th meeting of the Technical Committee was circulated vide letter no. NJB/ISAPM/2015 dated 9th June, 2015 to all members / officials attended the meeting.

Since no comments were received from any members, the minutes taken as confirmed.

Agenda-2 : <u>Reporting on action taken on the decision of the 4th meeting of the Technical</u> <u>Committee of ISAPM held on 13th April, 2015 at Conference Room of NJB,</u> <u>Kolkata.</u>

- 1) IJIRA has been assigned to carry out detail study for De-novo registration of all 40 (forty) enlisted vendors of core jute machinery under ISAPM.
- 2) IJIRA forwarded revised proforma for "De-novo registration" to all enlisted vendors. The documents provided by the vendors along with the filled-in proforma have been verified with the original documents during inspection.
- 3) 11 (eleven) enlisted vendors did not responded to IJIRA.
- 4) After receiving the filled-in formats, IJIRA completed physical verification at the site of 28 (twenty eight) enlisted vendors.
- 5) IJIRA submitted the report of the De-novo registration of 28 vendors before the committee and after threadbare discussion on the report, the committee decided as follows:
 - (A) Out of 28 vendors inspected by IJIRA, following 18 (eighteen) are approved and will continue with their enlistment under ISAPM.

- 6) Incentive will be calculated on the basis of Minimum Unit Basic Price of identical core jute machine, quoted by the enlisted vendors during De-novo assessment of IJIRA. The minimum unit basic price tabulated at **Annexure-C**, subject to final verification and confirmation by the Director, IJIRA.
- 7) Director, IJIRA will submit the revised report of De-novo registration to NJB after completing activities under (**B**) & (**C**) above.

Agenda-3 : Reporting of status on the progress of the scheme.

1) Committee noted the status report of the scheme and understood that the main reason for delay in processing of proposals / claims, at NJB and IJIRA were due to arriving at the average admissible unit basic price of different core jute machinery, till completion of the

De-novo-assessment of enlisted vendors. IJIRA has so far collected the current basic price of different core jute machinery, manufactured by enlisted vendors. Chairman, IJMA, Chairman, JPDEPC and other members present in the meeting agreed to accept the minimum basic price of each type of core jute machinery for calculation of incentive. Issuing of IPA and or calculation of the amount of incentive (@ 20% of the basic unit price) under the scheme, the minimum price of the machinery to be considered whereas for other non-core jute machinery the quoted price submitted by the applicant may be considered.

- (2) Investment under funding from own source (OS) : Two copies of the application in the prescribed format Annexure-A may be submitted by authorized representative of mills / JDP sector units at NJB with fees payable to IJIRA by Demand Draft for technical appraisal report, with a prior appointment positively. NJB should try to accord "In-principle approval" (IPA) within one month from the date of receipt of the proposal. For spot scrutiny, criteria-wise checking list of the proposal are mentioned below :
 - 1) Highlights of the proposal
 - 2) The company (jute mill / JDP unit) and its Management (details names etc.)
 - 3) Existing list of plants / machinery installed in the unit where the upgradation/ modernization is proposed.
 - 4) The concept of the project with the benefits to be achieved
 - 5) Location of the plant where the modernization / upgradation is being carried out
 - 6) Means of finance
 - 7) Change in profitability due to upgradation / modernization
 - 8) Details of vendor undertaking the modernization / upgradation with quotation
- (3) Application in the prescribed format of Annexure B, Form No. 1 should be submitted at NJB by the claimant for claim of incentive referring to the IPA issued by NJB. Additionally, original receipts of the payments made to vendors and bank certified bank statements should be enclosed with the claim application.
- (4) Investment under loan from bank finance (BF): Two copies of claim of incentive submitted by the claimants, under bank finance, may be submitted by authorized representative of mills / JDP sector units at NJB with fees payable to IJIRA by Demand Draft for technical appraisal report, for spot scrutiny with a prior appointment positively. Application in the prescribed format of Annexure B, Form No. 1. Additionally, the loan application, approval of loan by the bank, installment/s of disbursement of loan and viability assessment report made by the bank on viability of the project on which loan disbursed by the bank, for bank financed cases. Original receipts of the payments made to vendors and bank certified bank statements should be enclosed with the claim application.
- (5) IJIRA has been advised to prepare a common inspection template, made of metal, to be fixed on the gable of the machine before spot inspection on which claim of incentive has been made.
- (6) A board describing clearly the detailed phase-wise and date-wise installation machinery for the last five years under earlier Scheme No. 6.4 of Jute Technology Mission on which subsidy have been received from NJB to be fixed / installed in respective department for facilitating smooth inspection. Henceforth, format as per Annexure-E may be implemented.
- (7) The mill's to ensure that all machines which are being procured under ISAPM for which incentive is admissible to be embossed on the gable of the machine stating the name of the machine manufacturer, manufacturer serial number, date of manufacture, and type of machine. A metallic plate also to be fixed on the machines on which the inspection serial number, date of installation, date of inspection and signature/s of the inspectors to be mentioned during inspection.

- (8) Field inspection at applicant mill/s to be carried out once in a week, preferably on Wednesday, by the selected representatives from NJB, JC office and IJIRA. To clear the backlog initially inspection for two days preferably on Tuesday and Thursday per week may be fixed depending on exigencies. The detail list of pending inspection to be undertaken according to Annexure-D.
- (9) IJIRA has been advised to prepare techno-economic evaluation report of all the pending proposals / claims under the scheme before Durga Puja Vacation.
- (10) It was also decided that, the list of eligible machinery for Jute and JDP sector units under the RR-TUFS since been revised, the said revised list of machinery will be considered under ISAPM also.

Agenda-4 : Reporting on Proposed Modification of the Scheme

- (A) Chairman advised to include the MoT's- letter No.2/26/2014-JE/Jute dated 6th August,2015, in the agenda of the next Board Meeting scheduled to be held on 15th September, 2015 for discussion amongst members and decide on this issue.
- (B) Submit a suitable reply against the query made by the MoT vide No. 2/26/2014-JE/Jute dated 6th August, 2015.

Agenda-5 : Any other matter with the permission of the Chair.

Decisions have been taken on the following points :

- (A) Henceforth, all claimants of incentive under ISAPM should submit properly filled-in Form No.-1 enclosing relevant copy of document/s, wherever necessary, to the Secretary NJB, strictly as per the modified format (at Annexure-B) for release of incentive under ISAPM.
- (B) Original Invoice/s and documents of all new machinery on which incentive have been claimed after installation, under ISAPM should submit by claimant along with bank certified statement, must be countersigned by the Bank Manager.
- (C) Details of RTGS, Account No. on which the incentive to be transferred, IFS Code of the bank etc. to be intimated along with the claim application
- (D) Applicant should prepare a board stating name as per **Annexure-E** and to be placed in the office and concerned department mentioning department-wise statement of Subsidy & Incentive received from NJB under JTM and ISAPM respectively for the last five years.
