 As per decision taken in the 9<sup>th</sup> Sub Committee meeting of the JRMB, the modification of the Scheme guidelines are as follows (w.e.f 1<sup>st</sup> April,2019):

Existing Guidelines	Justification for Change	Proposed
The Operating Agencies of JRMB should purchase jute mill products like Jute Hessian / Jute & Jute blended fabric / yarn etc from the jute mill at mill gate price rate against proper invoice. The Jute Hessian / fabrics procured from the Jute Mills require further processing (Bleaching, Dyeing & Lamination etc.) for ready to use as Raw Material for the JDP manufacturer. The Sale Incentive for the JRMB Operating Agencies are calculated on the basis of the cost price of the materials purchased from the mill ( mill gate price + cost of transportation from the mill to the JRMB Operating Agency )	JRMB Operating Agencies often find lots of difficulties to procure & obtain Jute yarn / twines of desired quantity & quality from the composite Jute mills and deliver to the JDP units especially carpet / wall hanging manufacturing units on time.	However, it may not be implemented immediately and may be decided in the next committee meeting.
