References is invited to the Minutes of the 8th Meeting of the Sub Committee of JRMB Scheme (held on 21.01.2016) issued vide this office letter of even no. dated 11th February,2019.

In the said minutes at SI. No.9 at Pg 0 and 1, the following has been mentioned :-

In partial modification of the said minutes, the members of the 8th Sub Committee of JRMB scheme approved the following:

(a) The Jute Corporation of India (JCI), recently submitted documents at NJB office in support of their marketing experience in promoting and sell of JDP items. JCI applied to operate JRMB at SONALI, Dakshinapan Shopping Complex, Gariahat Road, and Kolkata - 700068 with a covered area of 1200sq.ft. The members of the Sub Committee has agreed that the documents submitted by JCI earlier towards their experience in operating JDP outlets is insufficient which resulted lack of understanding by the Committee. The fresh document revealed that JCI has sufficient experience in operating retail outlet, hence the Committee agreed for a fresh re-examination regarding the interpretation of marketing experience of JCI based upon the documents recently submitted by JCI. The Evaluation Sheet Criteria of JCI have been reviewed and the Committee recommended to incorporate The Jute Corporation of India as JRMB agency beside the other 5 nos. of selected JRMB agencies. The remaining portions of the minutes circulated vide NJB letter of even no. dated 11th February, 2019 stand unchanged.

In addition, the members of the 8th Sub Committee of JRMB scheme instructed to include the following ratification:

(b) An ambiguity have been cropped up regarding the date of effect of the revision in the Operational Guide lines in JRMB Scheme (where Sales Incentive and Operational Cost been merged vide minutes of the 7th Meeting of the Sub Committee of JRMB scheme held on 28.06.2018 and issued on 25.07.2018)

The Operating JRMB agencies got information on the changes in the Operational guidelines only after the end of the 1st quarter of 2018-19(April –June'2018). It has been noticed that some existing JRMB agencies have claimed for Operational Expenditure during the 1st Quarter of 2018-19 as per existing Operational guideline. Hence it is proposed that the date of effect of the Revision in the Operational Guide lines in JRMB Scheme as per the 7th Meeting of the Sub Committee of JRMB scheme to be effective from 01.07.2018 instead of 01.04.2018.
