The meeting was Chaired by the Jute Commissioner. On behalf of NJB, Dr. Mahadeb Datta, Jt. Director (IT) welcomed all the attendee members. Thereafter the agendas were taken up for discussion. The list of attendees present physically and virtually is enclosed at Annexure – I.

**Agenda 1: Confirmation of the Minutes of the 10th Technical Committee under CSAPM held on 10.04.2024**

The minutes of the 10<sup>th</sup> Meeting of the Technical Committee under CSAPM held on 10.04.2024, after being duly approved by the Chairman, were circulated to the members vide NJB's communication no. NJB/CSAPM/10<sup>th</sup>TC-Minutes/2024-25/11766 dated 19.04.2024.

Since, no further correspondence received in this regard, the minutes have been considered as approved by the Committee.

**Agenda 2: Action Taken Report on 10<sup>th</sup> Technical Committee (TC) meeting**

- Regarding revised Price-List: The Committee noted the actions taken by NJB as per direction of the 10<sup>th</sup> TC meeting.
- Regarding the machines involved for production of Jute Leaf Drink to be incorporated into the online CSAPM system: The Committee noted the actions taken as per direction of the 10<sup>th</sup> TC meeting.
- Matter related to the claims submitted by M/s S.L. Packaging Pvt. Ltd. (NJB-08-SLP-24082022-49) : The Committee advised NJB to consider the claim for further action.  
Matter related to the claims submitted by M/s Eco Jute Pvt. Ltd. (NJB-08-ECO-29082022-50): Since the concerned Vendor related to the instant claim has not completed the De-novo registration after giving sufficient time, it was decided by the Committee to close the claim.
- Regarding the matter of short receipt of subsidy against the "JUKI BAR TACKING MACHINE" supplied by M/s IIGM Pvt. Ltd. was represented by the Industry Association during 10<sup>th</sup> TC: The Committee noted the actions taken by NJB.

**Agenda 3: Matter related to De-novo Registration under CSAPM**

- **Revised recommendation of eligible core vendor for enlistment:**

The status of De-novo process was discussed in details during the meeting. Further to the 15 nos. of vendors (foreign & indigenous) enlisted during the previous meeting of the Technical Committee, based on the recommendation given by the Textiles



Committee, 5 more following vendors are approved by the Committee as enlisted under the Scheme.

▪ **Revised Price-List :**

After due deliberation, the revised price-list forwarded by the Textiles Committee, Mumbai vide mail dated 13.08.2024 has been approved by the Committee. The Chairman advised NJB to publish the same in [www.jute.com](http://www.jute.com)

▪ **Statement of advance payment received towards De-novo registration submitted by Textiles Committee, Mumbai :**

The matter was discussed at length. As per the submitted statement (as on 31.03.2024), it was observed by the Committee that balance of Rs.1,07,870/- is only available with Textile Committee.

Thus, it was proposed by the Committee that another requisition by the Textiles Committee may be forwarded to NJB in advance for smooth implementation of scheme.

The Chairman approved the proposal and requested Textiles Committee, Mumbai to do the needful in this regard.

**Agenda 4: Proposal received from JPDEPC & OSB Overseas Pvt. Ltd. regarding inclusion of Machine (Core & Non-Core) under the Scheme**

After detailed technical discussion, based on the proposal received from JPDEPC (Industry Association) & M/s OSB Overseas Pvt. Ltd. the Committee approved the Provisional

inclusion of the following machines/ equipment into the online LoI system under Core & Non-core category.

**Agenda 5: Status of online LOI, Claim under CSAPM**

The Committee noted that status of the Scheme. The Committee also opined that more involvement of the Industry Association/s is required for better disseminate of benefit amongst the Jute Diversified Industry. Secretary, NJB suggested that to facilitate credit linked proposal, a meeting may be organized with local Banks & JDP manufacturing Sector.

**Agenda 6: Any other issues with the permission of the Chair**

✓ **Miscellaneous issues:**

- Matter related to the claim submitted by M/s Alo (NJB-08-ALO-06102023-91) :

The matter was discussed at length. Vice-Chairman, JPDEPC and Sh. Anil Kariwala also highlighted the challenges of the tiny JDP Units to fulfill the criteria/s especially the bank loan related papers / documents as stipulated in the Scheme. The Chairman also highlighted the steps were taken by NJB towards modification of Scheme guidelines keeping view of such challenges are being faced by the JDP Units. However, the approval of Ministry is awaited.

Further, Chairman advised NJB to strictly follow the Operational Scheme guidelines while processing the claim. Secretary, NJB requested JPDEPC to forward a concrete



note in this regard so that it can be considered during upcoming preparation of outline of scheme under JTM 2.0.

It was also opined that NJB may again request to the concerned Bank to provide the desired documents/ papers.

- Matter related to the claim submitted by M/s Ashoka Exports (NJB-08-ASE-29032023-56 & NJB-08-ASE-17102023-92) :

Chairman advised NJB to follow the Operational Scheme guidelines while processing the claim. It was also opined that NJB may again request to the concerned Bank to provide the desired documents/ papers.

- 2 nos. of claims submitted by M/s Pankaj International (NJB-08-PNI-21032023-54 & NJB-08-PNI-03052023-65) rejected due to non-compliance of Scheme Guidelines :

The Committee noted the action and Chairman advised NJB to follow the Operational Scheme guidelines while processing the claim.

There being no other issues, the meeting ended with a vote of thanks to and from the Chair.
